The Legislative Ethics Committee has the authority to investigate complaints against sitting legislators for alleged violations of matters covered by Chapter 138A of the North Carolina General Statutes (the State Government Ethics Act) or Article 14 of Chapter 120 of the North Carolina General Statutes (the Legislative Ethics Act). Examples of matters covered by the State Government Ethics Act include use of public position for private gain; conflict of interest while taking legislative action; or receipt of a prohibited gift. Examples of matters covered by the Legislative Ethics Act include bribery; unethical personnel-related action; disclosure of confidential information; a violation of the criminal law by a legislator while acting in the legislator's official capacity as a participant in the lawmaking process; violation of an Ethical Principle and Guideline adopted by the Legislative Ethics Committee; or violation of a formal written advisory opinion adopted by the Legislative Ethics Committee.

NATURE OF THE COMPLAINT

Upon information and belief: Rep. Dobson has violated the State Government Ethics Act and/or Legislative Ethics Act by using his public position as a member of the General Assembly to solicit substantial compensation from the state government for lodging, meals and travel expenses which he claimed to have incurred in the performance of his duties as a legislator, but which were in fact paid by his campaign committee and not by himself. By taking official action to cause the government to make payments for a supposedly public purpose, he enriched his private fortunes with tax-exempt income.

Based on my examination of expense records of current legislators, no House members have taken action to receive more government payments for expenses paid by another source than Rep. Dobson and Rep. John Torbett, who is the subject of another complaint.

Rep. Dobson received government payments of more than \$90,000 from January 1, 2017 to June 30, 2020 for housing, meals and travel connected to legislative meetings but those expenses were largely paid by his campaign. For example, Rep. Dobson charged the government more than \$50,000 in this period for housing, but his campaign paid \$49,622 for his Raleigh apartment's rent, furnishing and utilities and for hotel rooms in the Raleigh area after he moved out of the apartment in 2019. This total includes housing payments of \$2,235 made after the Legislative Ethics Committee issued Ethical Principle and Guideline 11 on May 20, 2020. In addition, Dobson collected more than \$18,000 from the General Assembly for mileage, even though his campaign committee paid \$17,091 for his "gas" over the 42-month period, or more than \$400 a month. This includes \$283 for gas after May 20.

Rep. Dobson repeatedly took action in his official capacity to request, claim and accept payments from the public treasury for expenses that he knew were being paid by another source, namely his campaign. The exceptionally large sum of public money involved in his wrongdoing requires attention. It is difficult to see how the Legislative Ethics Committee cannot recognize his actions as unethical and a violation of state law that merits investigation and discipline in accordance with NCGS 138A-31, NCGS 120-102 or other provisions. In addition, he continued to take government subsistence and travel payments that were paid by another source after May 20, 2020 in violation of Ethical Principle and Guideline 11.

I am asking the members of the Legislative Ethics Committee to have the courage to enforce the State Government Ethics Act and Legislative Ethics Act, declare the actions of Rep. Dobson unethical, investigate and seek repayment of improperly obtained state funds as required of this Committee by NCGS 120-102(a)(8), and take whatever steps are appropriate to discipline a member of the General Assembly. Let me

be clear: I am not asking the Committee to retroactively apply Ethical Principle and Guideline 11. Dobson's actions after May 20, 2020 are clearly covered by that Guideline, **and** actions before that date are covered by state laws that prohibit legislators from taking official action, including an administrative decision, to request, charge or claim state funds for their private gain and for failing to repay those funds to the state. The Committee has an obligation under NCGS 120-102(a)(8) to "investigate," not just debate, "[u]pon receipt of information that a legislator owes money to the State. . . ."
